It is to bring to the notice of all Central Excise Assesseees/Manufacturers, Service Tax Assesseees, Trade and Industry and all other concerned, that in exercise of powers conferred vide section 37A of the Central Excise Act, 1944 (1 of 1944) read with

- (i) Rule 3 (2) of Central Excise Rules 2002 and Notification No. 29/2014- Central Excise (N.T.) dated 16.09.2014 issued by Central Board of Excise & Customs; and
 - (ii) Section 83 of the Finance Act, 1994 (32 of 1944) and Rule 3 of the Service Tax Rules 1994, as well as with Notification No. 21/2014-Service Tax dated 16.09.2014 issued by Central Board of Excise & Customs,
