Trade Notice No. 04/2014

Attention is invited to the Notification No. 27/2014-Central Excise (NT) and 20/2014-Service Tax, both dated the 16th September 2014 of the Department of Revenue in the Ministry of Finance, specifying the jurisdiction of the Commissioner of Central Excise and Service Tax, Surat I as reproduced in Annexure A to this Trade Notice.

2. Consequent upon such reorganization, the jurisdiction of Central Excise and Service Tax Divisions within the Commissionerate of Central Excise and Service Tax, Surat I is reorganized into three Central Excise Divisions and two exclusive Service Tax Divisions as detailed in Annexure B. Further, the jurisdiction of the Ranges of each of the Divisions of the Commissionerate of Central Excise and Service Tax, Surat I is reorganized as detailed in Annexure C.

3. Central Excise Divisions and Ranges will have jurisdiction over both Central Excise and Service Tax assesses except where the exclusive jurisdiction of the Service Tax Divisions and Ranges for Service Tax has been specified in this notice.

4. This Trade Notice supersedes all trade notices issued earlier in this regard.

5. All Trade Associations, Chambers of Commerce, and members of RAC are requested to publicize the contents of this Trade Notice amongst their members and constituents and all concerned for information and further necessary action.

6. Omissions and difficulties, if any, may kindly be brought to the notice at the earliest.

7. Reorganized jurisdictions detailed in this Trade Notice will come into effect from the 15th October 2014.

II	Areas on South side of Udhna-Magdalla road, west side of Surat-Navsari road upto Pandesara, North side of Pandesara upto round octroi naka covering Daxehwar Mahadev area, east side of Surat-Navsari Road, from old octroi naka to M. G. Road Udhna Plot no. 1 to 39 of Udhna Gam, Piplod, Umra upto Ramnath ghela Smashan bhoomi, Vesu, Bharthana, Althan, Govalak, Bamreli, Bhatar.
III	Areas of Sagarampura, Majura, Nanpura, Khatodara, Athwalines, Sonifalia, Vadifalia, Ruderpura, Chowk including Udhna Darwaja.

Lal Darwaja, Sumul Dairy Road, Rampura, Haripura, Mahidharpura, Manchharpura, Galemendi, Rughnathpura area of Surat City. East side of A. K. Road, Varachha Road, part of Kamrej taluka situated in the South of Tapi River and in the West of N. H. 8.
II	This range covers the area on west side of A. K. Road, Katargam, Fulpada, Mugalisara, Bhagal, Shahpor, Saiyadpura, Rani Talao, Nanavat, Ved Road, Dabholi, Singanpor, Toonki-Surat.
III	This range covers the area of Palsana Taluka in the West side of N. H. 8 and in the North of Surat-Bhusawal Railway line including Atroli Village, Vareli Village, Niyol Village.
IV	This range covers the area of Palsana Taluka in the East of N. H. 8 and in the North of Surat-Bhusawal Railway including Villages of Kadodara, Jolwa and Tatithaiya.
V	This range covers the area of Bardoli Taluka, Valod Taluka and part of Kamrej Taluka falling in the South of Tapi River and in the East of N. H. 8 and areas of both sides of Surat-Bardoli Road between border of Bardoli Taluka and Dastan Railway crossing covering the Villages of Gangadhara, Gangpur and Jatpor of Palsana Taluka. Mahuva Taluka, Vyara Taluka, Songadh Taluka, Uchhal Taluka and Nizar Taluka and part of Mandvi Taluka situated in the South of Tapi River.

Central Excise, Division-III	
Range	JURISDICTION
I	This range covers all units situated on North side of main Road, starting from Pandesara Society Bridge upto the end of the said Road in GIDC Pandesara.
II	Units on the left side of the main Road of Surat-Navsari Road i.e. Starting from Pandesara Police Station upto the end of the said Road and the units on the left side of Road of GIDC linking the main Road and the Road starting from GIDC residential colony.
III	This range covers all units falling on right side of the Road starting from GIDC Residential Colony upto the end of GIDC, units (other than those in GIDC Pandesara) on the Western side of Surat-Navsari Road, starting from Pandesara Society weigh bridge upto Cross-Road of Bhestan Village.
IV	This range covers units falling on the right side of GIDC East-West Road starting from erstwhile M/s. Shri Parmesh Silk Mills (Plot No. 50/52/1) and the units situated on the left side of the Road starting from erstwhile M/s. Empire Prints.
V	This range of cover all units falling on the South side of the GIDC east-west Road starting from M/s. Pandesara Dyes, upto the end of GIDC Pandesara and the Units in Bhestan Village, Unn Village (West side of Surat-Navsari Road) upto the Sachin-Dumas Road.

Central Excise, Division-IV(Service Tax)	
Range	JURISDICTION
I	This range covers partial area of Surat City adjoining to Ring Road from Udhna Darwaja to Delhi gate and Anjana area, Begam pura, Salabat pura, Rustam pura, Zampa Bazar, Nava pura, Gopi Talao, Inderpura.
II	This range covers the area on south side of Udhna-Magdalla road, west side of Surat-Navsari road upto Pandesara, North side of Pandesara upto Rundh Octroi Naka covering Daxeshwar Mahadev area, east side of Surat-Navsari road, from old octroi naka to M.G. Road, and Udhna Industrial area and village including Bamroli.
III	This range covers part of Surat city covering areas of Sagrampura, Majura, Nanpura, Khatodora, Athwgate, Sonifalia, Vadifalia, Ruderpura, Chowk Bazar.
IV	This range covers Udhna cross road to Unn Jakat naka & Functional area of New GIDC, Udhna upto railway track of Surat-Bombay line including parts of Bhedwad, Bhestan and Dindoli).
V	This range covers the area of Athwa gate to ONGC circle(including Piplod, Vesu, Udhna-Magdalla road, City light road and Ghod Dod Road, Bharthana, Althan and Bhatar Road.

Central Excise, Division-V(Service Tax)	
Range	JURISDICTION
I	This range comprises of the area of Pandesara, part of Bhestan village (west side of Bhestan-Navsari Road upto Unn Jakat Naka). Unn village (West side of Surat-Navsari Road) upto the Sachin-Dumas Road.
II	This range comprises of the area of West side of Surat Railway Station upto Delhi Gate, from Railway crossing of Sahara Gate upto Niyol Village on both sides of Surat-Bardoli Road, Umarwada, Puna Kumbharia Road, Saroli Village, Magob Village, V.D. Road, Lal Darwaja, Sumul Dairy Rod, Rampura, Haripura, Mahidharpura, Manchharpura, Galemandi, Rughnathpura area of Surat city. East side of A.K. Road, Varachha Road, part of Kamrej taluka situated in the south of Tapi river and in the west of N.H. 8.
III	This range comprises of the area on west side of A.K. Road, Katargam, Fulpada, Mugalisara, Bhagal, Shalpor, Saiyadpura, Rani Talao, Nanavat, Ved Road, Dabholi, Singanpor, Toonki-Surat.
IV	This range comprises of the area of Palsana taluka in the west side of N.H. 8 and in the north of Surat-Bhusaval Railway line including Atroli village, Vareli village, Niyol village and the area of palsana taluka in the East of N.H. 8 and in the North of Surat-Bhusaval Railway including villages of Kadodara, Jolwa and Tatithaiya.
V	This range covers the area of Bardoli taluka, Valod taluka and part of Kamrej taluka falling in the south of Tapi river and in the East of N.H. 8 and areas on both side of Surat-Bardoli road between border of Bardoli taluka and Dastan Railway crossing covering the villages of Gangadhara, Gangpur and Jatpor of palsana taluka, Mahuva taluka, Vyara taluka, Songadh taluka, Uchhal taluka and Nizzar taluka and part of Mandvi taluka situated in the south of Tapi river.
