Trade Notice No. 05/2014

Attention is invited to the Notification No. 27/2014-Central Excise (NT) and 20/2014-Service Tax, both dated the 16th September 2014 of the Department of Revenue in the Ministry of Finance, specifying the jurisdiction of the Commissioner of Central Excise and Service Tax, Surat II as reproduced in Annexure A to this Trade Notice.

2. Consequent upon such reorganization, the jurisdiction of Central Excise and Service Tax Divisions within the Commissionerate of Central Excise and Service Tax, Surat II is reorganized into three Central Excise Divisions and two exclusive Service Tax Divisions as detailed in Annexure B. Further, the jurisdiction of the Ranges of each of the Divisions of the Commissionerate of Central Excise and Service Tax, Surat II is reorganized as detailed in Annexure C.

3. Central Excise Divisions and Ranges will have jurisdiction over both Central Excise and Service Tax assesses except where the exclusive jurisdiction of the Service Tax Divisions and Ranges for Service Tax has been specified in this notice.

4. This Trade Notice supersedes all trade notices issued earlier in this regard.

5. All Trade Associations, Chambers of Commerce, and members of RAC are requested to publicize the contents of this Trade Notice amongst their members and constituents and all concerned for information and further necessary action.

6. Omissions and difficulties, if any, may kindly be brought to the notice at the earliest.

7. Reorganized jurisdictions detailed in this Trade Notice will come into effect from the 15th October 2014.

Jurisdiction of Surat-II Commissionerate as per Notification No. 27/2014- Central Excise (N.T.), dated 16.09.2014

COMMISSIONERATE	JURISDICTION
SURAT-II	Whole of District of Surat excluding the following areas:- (a) Areas of Surat city bound on the north by south bank of river Tapi, on the south by National Highway NH-6, on the east by National Highway NH-8 and on the west by Sachin-Magadalla road; (b) Area of Kamrej Taluka and Palsana Taluka bound by river Tapi on the north and on the south by Surat-Bhusaval railway line; (c) Areas of Mandvi Taluka on the south of river Tapi; (d) Area north to Kim river falling under Mangrol Taluka of Surat District; and (e) Areas of Bardoli and Mahuva Talukas.

ANNEXURE- B

Jurisdiction of Divisions of Surat-II Commissionerate

I	Entire Olpad taluka, Umarpada Taluka, area of Kamrej and Mandvi Talukas falling on North side of Tapi River, Mangrol taluka (except area falling in Ankleshwar Dn.III) i.e. South of Kim Mandvi Road and West of NH 8 upto river Kim.
II	Area of Choryasi taluka falling on North side of Tapi river i.e. Hazira, Sunvali, Mora Rajgari, Bhatlai, Damka, Vansva, Limla, Kawas, Bhatpor, Bhatha, Ichhapor, Bhesan, Pal, Palanpor, Rander, Pisad/Jahagirpura, Utran, Variyar. (2) Dumas Road from Rundh to Bhimpore i.e. Magdalla, Dumas, Bhimpore, Suttanabad.
III	Entire area of Sachin village i.e. GIDC Sachin, area of Choryasi Taluka on (1) the East side of Ahmedabad-Mumbai Railway line and South of Surat-Bhusaval Railway line upto GIDC Sachin (excluding area covered under Dn. I Surat) and (2) part of Palsana taluka falling in South of Surat-Bhusaval Railway line (3) the South of Magdalla-Sachin Road i.e. Abhva, Bhimrad, Sarsana, Khajod, Jiav, Budia, Talangpor, Gabheni, Ubor, Pali, Kansad.
IV(Service Tax)	This Division comprises of area from Ichhapore to Hazira, Sunvali, Mora, Rajgari, Bhatlai, Damka, Vansva, Limla, Kawas, Bhatpor and includes the area between right side of Surat-Dumas road (from ONGC circle to Dumas) upto to the Surat-Olpad taluka border (starting from Ichhapore circle upto Hazira light house) and areas opposite M/s ONGC(GAIL, GIDC Bhatpore)
V(Service Tax)	Entire Olpad taluka, Umarpada Taluka, area of Kamrej and Mandvi Taluka falling on North side of Tapi river, part of Mangrol taluka i.e. South of Kim Mandvi Road and West of NH 8 upto river Kim (II) Entire Area of Sachin village i.e. GIDC Sachin, area of Ghoryashi Taluka on (I) the east side of Ahmedabad-Mumbai Railway line and South of Surat-Bhusaval Railway line upto GIDC Sachin and (ii) part of Palsana taluka falling in South of Surat-Bhusaval Railway line (iii) The south of Magdalla –Sachin Road i.e. Abhva, Bhimrad, Sarsana, Khajod, Jiav, Budia, Talangpor, Gabheni, Ubor, Pali, Kansad. (III) Area starting from Ichhapore circle (towards Surat city i.e. north of river Tapi) to the borders of Surat (i.e. border of Olpad taluka on the north, border of Kamrej taluka on the east)

Range	JURISDICTION
I	Olpad Taluka except areas falling under Range-III and Range-IV, including Masma, Kudsad, Sayan, Western side of Mumbai-Ahmedabad Railway line of Kim; and part of Mangrol Taluka falling on Western side Mumbai-Ahmedabad railway line of National Highway No. 8 except area falling under Range-III and part of Kamrej Taluka falling on West of National Highway No. 8 and North of Tapi River.
II	Parts of Mangrol Taluka falling on Eastern side of National Highway No. 8 from Pipodra revenue limit to Kim Char Rasta and South of Kim-Mandvi road; entire Umarpada Taluka and part of Mandvi Taluka on North of Tapi river.
III	This range covers areas belongs to right side area of the road from Kim Railway station to Kim Char Rasta.
IV	This range covers left side area of the road from Kim Railway station to Kim Char Rasta and area of Mangrol Taluka viz. west side area of national highway No. 8 falling between river kim and Kim-Mandvi state highway.
V	Part of Kamrej Taluka falling on Eastern side of National Highway No. 8 and North of Tapi river upto pipodra revenue limit of Mangrol Taluka.

IV	This range covers M/s. Kribhco, M/s. IOC; areas between South bank of river Tapi & right side of Surat-Dumas road (from Rundh Jakat naka to Bhimpore)
V	This range comprises M/s. Reliance Industries Ltd. Mora village.

I	Areas south of Road No. 2 upto Road No. 3 excluding the area between East of Road No. 8 and South of Road No. 55 excluding the areas on East of Road No. 6 and South of Road No. 2 in the Engg. Zone of GIDC Sachin
II	East side of Surat-Navsari road beyond Unn Jakat Naka upto Sachin Railway over bridge, both East and West sides of Surat-Navsari road beyond Sachin Railway Over-bridge upto Mindhola River, area of Choryasi Taluka falling on the east side of Ahmedabad-Mumbai Railway line and South of Surat-Bhusaval line upto Road No. 2 of GIDC, Sachin.
III	Areas on South of Road No. 3 excluding areas in west of Road No. 6 (30 Meters wide Road) and areas East of Road No. 6 in the Engg Zone of GIDC, Sachin but including area East of Road No. 8 and South of Road No. 55 of GIDC, Sachin, areas of Choryasi Taluka falling on the South of Sachin-Magdalla Road upto Mindhola river i.e. Abhava, Bhimrad, Sarsana Khajod, Jiav, Budia, Talanpor, Gabheni, Uber, pali, Kansad(excluding the areas of GIDC Sachin included in the Range-I & II above).
IV	Areas on South of Road No. 3, GIDC, Sachin falling in West of Road No. 6 (30 Mtrs. Wide Road) but excluding the area of Range-III.
V	South of Surat-Busaval Railway Track in palsana Taluka.

I	Essar Group of companies & service providers offices situated in Nand Niketan Township, 27 th KM, Hazira-Surat road, PO Nand Niketan Township, Pin 390270 (Ideal resources, Exault, Rockwell structures)

II	Hazira, Sunvali, Mora, Rajgari, Bhatlai, Damka, Vansva, Limla, Kawas, Bhatpor, Bhatha, Ichhapor, Bhesan, except the jurisdiction of Range-I & Range-II of this Division.
III	Larsen & Tourbo group of Companies, Mora village.
IV	This range covers area between north bank of river Tapi & left side of Surat-Hazira road upto M/s. NTPC(M/s. Kribhco, M/s. NTPC, Kawas, M/s. BPCL, M/s. IOC, ONGC, GAIL, ABG Cement)
V	This range covers area between South bank of river Tapi & right side of Surat-Dumas Road upto the coastal area (from Rundh Jakat Naka to Bhimpore). ABG Shipyard, Ultratech Cement, GMB, Magdalla Port area.

Range	JURISDICTION
I	Entire Olpad taluka, Umarpada Taluka, area of Kamrej and Mandvi Talukas falling on North side of Tapi river, Mangrol taluka i.e. South of Kim Mandvi Road and West of NH 8 upto river Kim.
II	Area starting from Olpad-Surat border to Adajan patia. This area covers the area between the Rander-Olpad road & River Tapi and the areas on the north of Morabhagal to Bhesan Octroi on the Bhesan road.
III	Area on the north of river Tapi, starting from Bhata village to west of Rander-Olpad road and south of Morabhagal to Bhesan Octroi on the Bhesan Road(covering the area of Ramnagar, Palanpur, pal, Ajajan, Anand Mahal road)
IV	Entire Area of Sachin village i.e. GIDC Sachin, area of Choryasi Taluka (i) on the East side of Ahmedabda-Mumbai Railway Line and South of Surat-Bhusaval Railway line upto GIDC Sachin and (ii) South of Magdalla-Sachin Road i.e. Abhva, Bhimrad, Khajod, Jiav, Budia, Talangpor, Gabheni, Ubor, pali, Kansad (iii) Area of SEZ Surat & textile Apparel park in Sachin.
V	Part of palsana taluka falling on the East & West of NH 8 in South of Surat-Bhusaval Railway line.
