Attention is invited to the Notification No. 27/2014-Central Excise (NT) and 20/2014-Service Tax, both dated the 16th September 2014 of the Department of Revenue in the Ministry of Finance, specifying the jurisdiction of the Commissioner of Central Excise and Service Tax, Daman as reproduced in Annexure A to this Trade Notice.

2. Consequent upon such reorganization, the jurisdiction of Central Excise and Service Tax Divisions within the Commissionerate of Central Excise and Service Tax, Daman is reorganized into five Central Excise and Service Tax Divisions as detailed in Annexure B. Further, the jurisdiction of the Ranges of each of the Divisions of the Commissionerate of Central Excise and Service Tax, Daman is reorganized as detailed in Annexure C.

3. This Trade Notice supersedes all trade notices issued earlier in this regard.
