Attention is invited to Trade Notices No.01/2014& 05/2014 both dated 09-10-2014 and 11/2014 &12/2014 both dated 14-10-2014 issued by this office. In these Trade Notices, the following amendments are made with effect from 15-10-2014.

2. Consequent to Notification No.31/2014-Central Excise (N.T) dated 15th October, 2014 amending the Principal Notification No.27/2014- Central Excise (N.T) dated the 16th September, 2014 of the Department of Revenue in the Ministry of Finance, the following amendments are made:
