2. Point wise information sought by the applicant is as under:-

**Point No. 1 & 2:** As per Recruitment Rules for the post of LDCs under CBEC notified vide G.S.R. 146 dated 04.06.2013 issued from F. No. A-12018/06/2012-Ad.III B, the cadre of LDCs is being maintained at Commissionerate level/Sector Level (comprising of more than one Commissionerates came into existence during the course of time) and promotion from the feeder grade to the grade of LDCs is being handled by the respective Commissionerates/Sectors.

**Point No. 3:** At Zonal level, in the Cadre Control Unit, Chief Commissioner Officer, Vadodara, combined seniority of the LDCs of all sectors of the combined cadre of Gujarat is being maintained, wherein seniority of the officers is being fixed as per their promotion orders. Therefore, the officers who were promoted in the grade of LDC first, have been kept above in the seniority list to the officers who were promoted in later stage, in their respective sectors.

**Point No. 4:** Year wise vacancy in the grade of TA as per available records since 2010 to 2019 is as under:
