Please refer to your letter F.No.IV/16-55/CCO/RTI/2019 dated 15.03.2018 on the above subject matter.

2. Point wise reply of the RTI application by the applicant is as under:-

**Point 1 & 2:** Vacancies in the grade of Executive Assistant for the required date, i.e. 01.03.2019, is not available in this office as the vacancy position has been being calculated as on crucial date for eligibility of promotion from the feeder grade, i.e. as on 01.01.2019.

**Point No. 3:** The post of Executive Assistant has been emerged after merging of the grade of Sr. Tax Assistant and Deputy Office Superintendent (DOS) vide CBEC's (now CBIC) letter dated 18.12.2013 and accordingly post of Executive Assistant has been notified by Recruitment Rules published vide GSR 741 (E) dated 28.09.2015. As per RR-2015 of the grade of EA, 40% posts are to be filled through Direct Quota and 60% through Promotion Quota. Since total Sanctioned strength for Executive Assistant in the combined cadre of Gujarat is 515 and the RR of EA is post based, the Sanctioned strength for Direct Quota is 206 (40% of 515) and for Promotion quota is 309 (60% of 515). Accordingly, requisition for Direct Quota appointment to SSC has been forwarded as under:

\* 4 officers are transferred on ICT basis which are considered against DR Quota posts. Out of 309 Promotion quota posts, as on 01.01.2019, 90 EAs are working, therefore in total 219 posts are vacant for PR quota, as on 01.01.2019.

**Point No. 5.** No direct recruitment is done in the grade of EA for the year 2014, 2015, 2016, 2017 & 2018.


**Point No. 6.** The Grade of Executive Assistant came in existence after merging of the grade of Sr. Tax Assistant and Deputy Office Superintendent (DOS) vide CBEC's (now CBIC) letter dated 18.12.2013 and accordingly post of Executive Assistant has been notified by Recruitment Rules published vide GSR 741 (E) dated 28.09.2015. Thereafter, no promotion in the grade of EA has been made as per RR of EA.
