Subject : **Chain of Nomination (Link Officer) after introduction of GST 01.07.2007 for review purpose – matter reg. -**

Kind attention is invited to this office clarification vide F.No.V/02-07/Review Committee/CCO/RC/2014 dated 21.05.2015, whereby on the backdrop of the directions contained in the Office Order No.220/2012 dated 23.11.2012 and 28.08.2014 issued by the Board, this office had issued Office Order dated 02.12.2014, as amended by Office Order dated 19.12.2014, specifying therein the chain of Nomination (Link Officers) in the grade of Pr.Commissioners/Commissioners within Vadodara Zone.

2. Further, vide Para 3 thereof, it has been clarified that in case a Commissioner has proceeded on leave or is transferred or is not present for any other reason, the charge (**administrative, as well as, for Review purposes**) of the said Commissioner would automatically get assigned to first Link Officer specified in Office Order dated 02.12.2014, as amended by Office Order dated 19.12.2014. In case, the First Link Officer happens to be a member of the Review Committee, then for the limited purpose of review, the Second Link Officer would function as the member of Review Committee.

3. However, post-introduction of GST and resultant Organizational restructuring, by modifying the Office Order dated 02.12.2014, as amended by Office Order dated 19.12.2014, this office has issued another Office Order vide F.No.II/03-17/CCO/2016 dated 06.07.2017 specifying therein fresh chain of Nomination (Link Officers) in the grade of Pr.Commissioners/Commissioners within Vadodara Zone.

4. Although necessary clarifications with regard to the constitution of the Review Committee of Commissioners as mentioned above, remains issued by this office vide above referred letter dated 21.05.2015 regarding the flow/chain of Nomination (Link Officer), there appears to be apprehensions in view of issuance of Office Order dated 06.07.2017 regarding fresh nomination of Link Officers.

5. In this regard, Board vide Office Order No.15/2017 (issued vide F.No.390/Review/49/2017-JC) dated 08.08.2017, has also already clarified that in the case where a member of the Review Committee proceeds on leave, transfer or is absent for any other reason, the first nominated link officer would function as a member of the Review Committee, and where the first nominated link officer happens to be a member of the Review Committee, the second nominated link officer would function as member of the Review Committee.

6. Therefore, it is hereby clarified that, except for the reference to the earlier Office Orders dated 02.12.2014/ 19.12.2014, which shall now be read as "**Office Order F.No.II/03-17/CCO/2016 dated 06.07.2017**", there is no other change to the clarifications already given by this office vide letter dated 21.05.2015, which shall prevail.
