

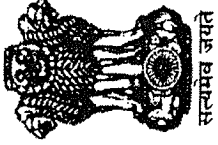

MINUTES OF DPC MEETING FOR PROMOTION TO THE GRADE OF LDC (Pre-restructured) HELD ON 12.06.2015

Through Office Note bearing F. No. II/3-22/CCO/2014 dated 28.04.2015 issued by the Additional Commissioner (CCO), Central Excise & Customs, Vadodara Zone, Vadodara, the Committee was informed that the Central Board of Excise & Customs, New Delhi vide its communication under F. No. A.32022/70/203-Ad.III.A dated 26.09.2009 has directed for implementation of Hon'ble Andhra Pradesh High Court's Common order dated 02.03.2005 and 07.03.2005 passed in writ petition No. 7963/2004 and writ petition No. 2378/2005 filed by Shri S.S.L. Narayana & W. P.45/2005 filed by Shri C. Gridhar Prasad and others.

2.0 COMPOSITION OF THE DPC :

3.1 The Chief Commissioner, Central Excise, Customs & Service Tax, Vadodara Zone, Vadodara being Cadre Controlling Authority for the combined cadre of Gujarat Zone has constituted a DPC for the purpose. As per the Central Excise and Land Customs Department (Group 'C' posts) Recruitment Rules, 1979, DPC was constituted as under:

3.0 Vacancy position :

3.1 The committee was informed vide aforesaid office note dtd. 28.04.2015 that as per the direction conveyed under Board's letter F.No. A. 32018/14/2008-Ad.III A dated 06.02.2009 in W.P. No. 2378/2005 and W.P. 45/2005 and on the basis of recommendation of the review DPC held on 26.06.2014, total 197 Group "D" officers were promoted to the grade of Lower Division Clerk (Pre-restructured) vide EO. No. 66/2014, 67/2014 and 72/2014 dated 02.07.2014 and 14.07.2014 w.e.f. 19.07.2001 and 20.07.2001 in the Combined Cadre of Gujarat Zone under qualifying examination quota and Seniority -Cum-fitness quota and against chain vacancy.

3.2 Further, 34 vacancies have arisen due to cancellation of promotion order on account of refusal/not joining on promotion in the grade of Lower Division Clerk (pre-restructured) vide EO. No. 10/2015 dated 25.03.2015 and 17/2015 dated 27.04.2015. These 34 vacancies are to be filled up by granting promotion from Gr. D officers as per the old RRs of the Lower Division Clerk vacancies prior to restructuring and are required to filled up on the basis of Para 7 in the DOPT's instruction letter dated 25.01.1996 .

3.3 As per the old RRs of the LDC, vacancies prior to restructuring are required to be filled up as under:

"as per Central Excise & Land Customs Group "C" Recruitment Rules, 1979 as amended vide Notification No. 589 and further amended vide Govt. of India, Ministry's of Personnel, Public Grievance and Pensions (Deptt. Of Personnel & Training) New Delhi's letter F. No. 49011/1/96-Estt. Dtd. 25.01.1996, 15% of the vacancies are to be filled up from the educationally qualified (Matriculation Pass) Group D Staff/Lab Attender/Record Keeper, out of 15%, 10% of the vacancies are to be filled on the basis of departmental qualifying test with 05 years of regular service in Gr. 'D' or Gr. 'D' and record keeper taken together and 5% on the basis of Seniority-cum-Fitness. In other words, 2/3 of vacancies earmarked are to be filled on the basis of departmental qualifying test and 1/3 of vacancies are on the basis of Seniority-Cum-Fitness."

3.4 The Committee was informed as per Recruitment Rules prevailing during the vacancy year 2001-2002 as mentioned above, 2/3rd of total vacancy (i.e. 2/3 of 34 = 20) were to be filled up by promoting eligible Group "D" officers on the basis of departmental qualifying exam quota and 1/3rd (i.e. 1/3rd of 34 = 14) by promoting Eligible Group "D" officers on the basis of Seniority -Cum-Fitness basis quota.

4.0 Consideration List:

Two consideration lists were placed before the Committee for assessment of suitable officers for promotion to the grade of LDC.

4.1 **Departmental Qualifying Exam Quota:** One list consisting of 28 officers were placed before the Committee to assess the suitability for promotion to the grade of LDC as on 20.07.2001. Thus out of list of 28 officers, a select panel of **20 officers** was to be drawn.

4.2 **Seniority -Cum-Fitness Quota:** One list consisting of 21 officers was placed before the Committee to assess the suitability for promotion. Out of these 20 officers, a select panel of **14 officers** was to be drawn.

5.0 Criteria adopted by the DPC:

5.1 The Committee had assessed the officer on the basis of ACRs of preceding 05 years (i.e. 1995-96 to 1999-2000) from the effective date of promotion i.e. 20.07.2001. The Committee also took into consideration the Vigilance Status of the officers as on 20.07.2001 and also considered the outcome of any Departmental proceedings/Prosecution/Completion of date of penalty in case of officers facing the same as on relevant date.

6.0 Findings of DPC:

The Committee recorded its findings in respect of the officers falling within the Consideration Zone as follows:

The committee examined overall service records of the officers in the consideration lists along with the ACRs for the relevant years.

In the case of Shri S.M. Chaudhary, Sr. No. 6 of the consideration list of Seniority Cum Fitness Quota, the DPC has found that ACRs for the years 1996-97 to 1998-99 could not be initiated as the officer was absent from duty during the period. The DPC has therefore, considered the ACRs for the preceding years i.e. for the years 1992-93, 1993-94, 1994-95.

In the case of Shri Ranchhodbhai S Patel, Sr. No. 16 of the consideration list of Departmental Exam Quota, the Committee observed that the ACR dossiers placed before them contained reconstituted ACRs for the relevant years. It was mentioned in the dossier that the original ACRs were not traceable. Accordingly, the committee has decided to defer the case of Shri Ranchhodbhai S Patel for want of original record.



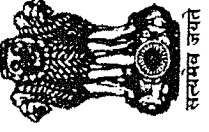



3. Criteria adopted by the Committee:

The present Committee followed the same criteria for selection/assessment of officer as adopted by the Original DPC that had met on 26.06.2014 & 12.06.2015 to consider the cases of two officers for promotion to the grade of LDC (Pre-restructured).

A. Shri Desani Vanshyam D

3.1 Vide Office Note dtd. 23.07.2015, the Committee was informed that the Departmental Promotion Committee that met on 26.06.2014 for considering the cases of Gr. 'D'/Lab Attender/Record Keeper for promotion to the grade of LDC (Pre-restructured) w.e.f. 20.07.2001 had observed in the case of Shri Desani Vanshyam D

(at Sr. No. 74 of consideration of Deptt. Exam Quota List 2 and Sr. No. 1 of the extended panel for Departmental Exam Quota) that the ACR/APAR dossiers for the relevant years 1995-96 to 1999-2000 were not placed before the committee, hence the committee deferred his consideration for want of original record.


3.2 The findings of DPC were communicated to the Joint Commissioner (P&V), C.Ex. & Customs, Surat-I vide letter F. No. II/3(CON) 05/DPC/2014 dated 23.06.2015, with reference to which, the Deputy Commissioner, Cus. Divn. Surat vide letter no. II/39(Vig.)53/2013-14 dated 01.07.2015 has forwarded the original dossier of Shri V.D. Deshani, Havalidar containing APAR/ACR (including grading) for the relevant period of years 1995-96 to 1999-2000 for further consideration of the officer for promotion to the grade of LDC (pre-restructured).

3.3 The Committee examined the case of Shri V.D. Deshani for promotion to the grade of LDC (Pre-restructured) on the basis of overall assessment of the APARs and found the officer 'Fit' for promotion to the grade of LDC (Pre-restructured) w.e.f. 20.07.2001. The Committee also placed Shri V.D. Deshani above Shri Patel Nanabhai R at Sr. No. 02 of the Extended Panel of Deptt. Exam Quota drawn by the DPC that met 26.06.2014.

B. Shri Ranchhodbhai S Patel

4. Vide the Office Note dtd. 23.07.2015, the Committee was informed that the Departmental Promotion Committee that met on 12.06.2015 for considering the cases of Gr. 'D' for promotion to the grade of LDC (Pre-restructured) w.e.f. 20.07.2001 had observed in the case of Shri Ranchhodbhai S Patel (at Sr. No. 16 of the Departmental Exam Quota list) that the ACR dossiers placed before the committee contained reconstituted ACRs for the relevant years. It was mentioned in the dossier that the original ACRs were not traceable; the same were re-comprised without reviewing it, hence the committee deferred his consideration for want of original record.

4.1 The findings of DPC were communicated to the Joint Commissioner (P&V), C.Ex. Ahmedabad-III vide letter F. No. II/3(CON) 05/DPC/2014 dated 22.06.2015. With reference to the same, the Additional Commissioner, Central Excise, Ahmedabad-III vide letter no. II/39(CON)43/2014-15 dated 09.07.2015 has communicated that the Original APAR was not received to their office from the earlier posting of Shri Ranchhodbhai S Patel, hence, the re-constituted ACRs which were placed before the DPC for the years 1995-96 to 1999-2000 have been reviewed by the then officers and the same are furnished for further consideration of the officer for promotion to the grade of LDC (pre-restructured) w.e.f. 20.07.2001.



4.2 The Committee examined the case of Shri Ranchhodbhai S Patel for promotion to the grade of LDC (Pre-restructured) on the basis of overall assessment of the APARs and found the officer 'Fit' for promotion to the grade of LDC (Pre-restructured) w.e.f. 20.07.2001 subject to condition that the concerned Commissionerate should certify that ACR placed before the committee is valid and genuine. On his promotion to the grade of LDC (Pre-restructured), his seniority is fixed above Shri R.A. Kodyatar at Sr. No. 17 of the Panel of Deptt. Exam Quota drawn by the DPC that met 12.06.2015.

5. Findings of the Committee :

On the basis of overall assessment of the APARs of relevant period and criteria adopted by the Original DPC that met on 26.06.2014 & 12.06.2015, the present Committee considered the above 02 cases and recorded its findings as under:
