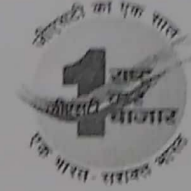

Vacancy year 2017-2018:-

4. VACANCY POSITION:

4.1 Vide office note dated 19.06.2017, the Departmental Promotion Committee was informed that in the grade of Superintendent, **153** posts shall be available for General category, **95** for SC category and **06** posts for ST category (Total 254 posts) during the vacancy year 2017-18. The same are to be filled up by promotions.

**Vacancy year 2018:-**

3.0 VACANCY POSITION:

3.1 Vide office note bearing F.No.II/03-11/CCO/2018 dated 20.06.2018 issued by the Additional Commissioner, CCO, Central Excise & Customs, Vadodara Zone, Vadodara, the Committee was informed that there are 225 vacancies, out of which 75 vacancies were on account of ad-hoc promotion of Superintendent to Assistant Commissioner vide Board's Order No.79/2018 dated 11.05.2018. For the balance of 150 regular vacancies, 37 posts are available for General category, 96 reserved for SC category and 17 posts reserved for ST category.

Vacancy year 2019:-

**3. Vacancy Position:**

3.1 The Committee was informed vide Office Note bearing F.No. II/03-28/CCO/2018 dated 29.03.2019 issued by the Additional Commissioner (CCO), CGST & CE, Vadodara Zone, Vadodara, that in total 156 posts in the Grade of Superintendent are lying vacant in the combined cadre of Central Goods & Service Tax, Central Excise and Customs, Gujarat Zone out of which 85 posts are unreserved and 71 posts are reserved for SC category; no post is vacant in the ST category. It was observed that the said 156 vacancies include 75 vacancies created due to promotion of 75 Superintendents to the Grade of Assistant Commissioner

Vacancy year 2020:-

**3. Vacancy Position:**

3.1 The Committee was informed vide Office Note bearing F. No. II/03-45/CCO/2019 dated 27.12.2019, issued by the Joint Commissioner (CCO), GST & CE Zone, Vadodara, that in total 82 posts in the Grade of Superintendent are lying vacant in the combined cadre of Goods & Service Tax and Central Excise Zones of Vadodara & Ahmedabad and Customs Zone of Gujarat, for vacancy year 2020. Out of these 82 posts of Superintendents, 39 are unreserved (UR), 42 are reserved for Scheduled Caste (SC) category and 1 is reserved for Scheduled Tribe (ST) category.
