2. In this regard, the required information is appended below:



Sub : Reference CAT's Order dated 10.01.2020 in OA No. 438/2015 received on 04.02.2020 : Request for regularization and grant of pension to Smt. Kesharben N. Pagar, Retired on 30.08.2013 as Casual Labourer (Temporary Status) - reg.

Please refer to your letter F. No. I/22-03/CCO/2020 dated 11.02.2020 on the above subject.

2. Vide the above mentioned letter, a representation of Smt. Kesarben N. Pagar, Casual Labour (retired on 31.08.2013) has been forwarded to this office. The representation has been made in reference to CAT's Order dated 10th January, 2020 in OA No. 438/2015. The Hon'ble CAT vide the said order has allowed the withdrawal of the OA and granted liberty to the applicant to file representation for regularization. Accordingly the applicant has filed the above representation.

3. With regard to the regularization in respect of retired CL-TS, the Board vide F. No. A.12034/60/2014-Ad.IIIB dated 31.12.2015 communicated that :

"the CL-TS who have been retired can not be regularized. A proposal for regularization of retired CL-TS was taken up with DOPT and they did not agree to the proposal"


4. Subsequently, the Board vide letter F. No. C.18013/25/2018-Ad.IIIB dated 08.05.2019 (forwarded vide CCO's letter F. No. II/39-11/CCO/2019 dated 22.05.2019) again called for the details of the retired casual labourers to submit the same to DOPT for approval regarding their regularization. Accordingly, the details of the retired casual labour including the name of Smt. Kesarben N. Pagar, Casual Labour were forwarded to the CCO vide this office letter of even no. dated 23.08.2019 for onward submission. It appears that the matter is pending with the Board for decision.

5. The above facts are brought to your notice for information and necessary approval, so that the same may be communicated to the applicant.
