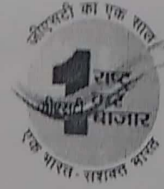

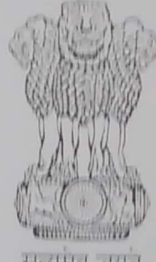

2. The details of Sanctioned strength & vacancy position in the grade of Sr. Tax Assistant prior to restructuring are as under:-

Sanction Strength in the grade of SR. TAX ASSISTANT in the combined cadre of Gujarat Zone from 2002 to 01.08.2014

1.	Posts sanctioned as per Ministry's letter F.No. A-11013/4/2002-Ad.IV dated 5.6.2002 for the grade SR TA	361
2.	Additional posts of SR. TA sanctioned vide Ministry's letter F.No. A-11013/12/2007-Ad.IV dated 16.08.2007	14
3.	Total Sanctioned Strength	375

3. Prior to implementation of restructuring, the last DPC for promotion to the grade of Sr. Tax Assistant was held in August 2014 for 242 vacancies for the year 2014-15 (upto 31.03.2015) to fill up 242 pre-restructured posts of Sr. Tax Assistant against which 32 officers have been promoted vide EO No. 85/2014 dtd. 04.08.2014. Remaining 210 vacancies (158 Gen., 36-SC, 16-ST) were not filled for want of eligible officers.
